



SecureCare III repriced in AZ and IN and now available in DC, ND and SD

Effective today, June 28, 2023, rates for SecureCare [™] III, a long-term care (LTC) and nonparticipating whole life insurance policy, were decreased by 25 percent across all case scenarios in Arizona and Indiana.

All pending applications in Arizona and Indiana that have an effective date on or after June 28, 2023, will automatically be eligible for and receive the new pricing. This will result in a face amount that is higher than originally illustrated.

And the good news doesn't end there: SecureCare III is now available in Washington DC, North Dakota and South Dakota.

This means SecureCare III and its new rates are now available in all states except Delaware and South Carolina.¹

These agreements provide for the payment of a monthly benefit for qualified long-term care services. These agreements are intended to provide federally tax qualified long-term care insurance benefits under Section 7702B of the Internal Revenue Code, as amended. However, due to uncertainty in the tax law, benefits paid under these agreements may be taxable. Please ensure that your clients consult a tax advisor regarding long-term care benefit payments, or when taking a loan or withdrawal from a life insurance contract.
